# **Privacy Policy**

### INTRODUCTION

CR3ATORS LAB LTD. ("CR3ATORS LAB", "**us**" or **we**) respect your privacy and are committed to safeguarding your personal information by complying with this policy.

#### This policy outlines:

- How we collect, use, disclose, and protect the personal information of our customers, event participants, community members and website users ("you").
- The types of information we may collect from you or that you may provide when you sign up for or attend our events, respond to our surveys or electronic communications, engage with any of our services, or visit the website <a href="www.blockandchange.com">www.blockandchange.com</a> or any related websites we operate.
- Our practices for collecting, using, maintaining, protecting, and disclosing that information.

Privacy laws generally define "personal information" as any information about an identifiable individual, which includes information that can be used on its own or with other information to identify, contact, or locate a single person.

This policy applies to information we collect, use, or disclose about you:

- On the Block&Change website or any related websites operated by us, including event-specific websites.
- Relating to events organized by CR3ATORS LAB, including any information gathered during the event registration process or over the course of the event itself.
- In email, text, and other electronic messages between you and CR3ATORS LAB.
- Through mobile and desktop applications you download from this website, or which are used for CR3ATORS LAB events.
- When you interact with our advertising and applications on third-party websites and services if those applications or advertising include links to this policy.
- Through any surveys organized by CR3ATORS LAB.

Our website may include links to third-party websites, plug-ins, services, social networks, or applications. Clicking on those links or enabling those connections may allow the third party to collect or share data about you. If you follow a link to a third-party website or engage a third-party plugin, please note that these third parties have their own privacy policies and we do not accept any responsibility or liability for these policies. We do not control these third-party websites, and we encourage you to read the privacy policy of every website you visit.

We encourage you to please read this policy carefully to understand our policies and practices for collecting, processing, and storing your information. If you do not agree with our policies and practices, your choice is not to use our website or any program or service we offer through our website or that is linked to this policy. Similarly, if you do not agree with our policies and practices, you are not eligible to participate in our events, programs or services.

In order to actively participate in an CR3ATORS LAB event, program or service, you must affirmatively agree to this policy. By accessing or using this website or any program or service we offer through our website or that is linked to this policy, you indicate that you understand, accept, and consent to the practices described in this policy. This policy may change from time to time (see "Changes to Our Privacy Policy" below). Your continued use of this website or any program or service we offer through our website or that is linked to this policy after we make changes indicates that you accept and consent to those changes, so please check the policy periodically for updates.

### INFORMATION WE COLLECT ABOUT YOU

We collect and use several types of information from and about you, to provide you with a better experience and to achieve our mision, vision and values. The information we collect includes:

• **Personal information**, that we can reasonably use to directly or indirectly identify you, such as your name, age, e-mail address, Internet protocol (IP) address, user name or other similar identifier, location, event and developer feedback, and any other identifier we may use to contact you ("**personal information**").

We provide an opportunity for any user to unsubscribe from or opt-out of contact for marketing purposes on an ongoing basis by using the unsubscribe mechanism at the bottom of our e-mails, or e-mailing us.

- Non-personal information, which means information that does not directly or indirectly reveal
  your identity or directly relate to an identifiable individual, such as or statistical or aggregated
  information. We may derive non-personal statistical or aggregated data from personal
  information. For example, we may aggregate personal information to calculate the percentage of
  users accessing a specific website feature.
- **Technical information**, including your login information, browser type and version, time zone setting, browser plug-in types and versions, operating system and platform, or information about your internet connection, the equipment you use to access our website(s), and usage details.
- Non-personal details about your website interactions, including the full Uniform Resource
  Locators (URLs), clickstream to, through and from our website(s) (including date and time),
  products you viewed or searched for, page response times, download errors, length of visits to
  certain pages, page interaction information (such as scrolling, clicks, and mouse-overs), methods
  used to browse away from the page, or any phone number used to call our customer service
  number.

### HOW WE COLLECT INFORMATION ABOUT YOU

We collect information through different methods, including:

- **Direct interactions with you when you provide it to us**, for example, by filling in forms and surveys, or corresponding with us by phone, email, or otherwise.
- Your participation in our events may also provide information for us to publish or display through participating in our events.
- Automated technologies or interactions as you navigate through our website. Information collected automatically may include usage details, IP addresses, and information collected through cookies and other tracking technologies.
- Third parties or publicly available sources, for example, our business partners.

## Information you provide to us

The information we collect directly from you on or through our websites may include:

- Information that you provide by filling in forms. This includes information provided at the time of
  registering for an event, subscribing to any service we may offer from time to time, or requesting
  information or services from us. We may also ask you for information when you enter a contest
  or promotion sponsored by us, and when you report a problem with our websites or services.
- Records and copies of your correspondence (including email addresses), if you contact us.
- Your responses to surveys that we might ask you to complete for research or other purposes.
- Details of any transactions you carry out on our websites or those of our technology partners.
- Your search gueries on our website.

# Information We Collect Through Cookies and Other Automatic Data Collection Technologies

As you navigate through and interact with any of our websites, we may use cookies or other automatic data collection technologies to collect certain information about your equipment, browsing actions, and patterns, including:

- Details of your visits to our websites, including traffic data, location data, logs, and other communication data and the resources that you access and use on a website.
- Information about your computer and internet connection, including your IP address, operating system, and browser type.

The information we collect automatically is statistical information and may include personal information, which we may maintain it or associate it with personal information that we collect in other ways or that we receive from third parties. It helps us to improve our websites and to provide a better and more personalized service, including by enabling us to:

- Estimate our audience size and usage patterns.
- Store information about your preferences, allowing us to customize our websites according to your individual interests.
- Speed up your searches.
- · Recognize you when you return to our websites.

The technologies we use for this automatic data collection may include:

- Cookies (or browser cookies). A cookie is a small file placed on the hard drive of your
  computer. You may refuse to accept browser cookies by activating the appropriate setting on
  your browser. However, if you select this setting you may be unable to access certain parts of our
  Website. Unless you have adjusted your browser setting so that it will refuse cookies, our system
  will issue cookies when you direct your browser to our Website.
- Flash Cookies. Certain features of our Website may use local stored objects (or Flash cookies)
  to collect and store information about your preferences and navigation to, from, and on our
  Website. Flash cookies are not managed by the same browser settings that are used for browser
  cookies.
- Web Beacons. Pages of our Website and our e-mails may contain small electronic files known
  as web beacons (also referred to as clear gifs, pixel tags, and single-pixel gifs) that permit the
  Company, for example, to count users who have visited those pages or opened an email and for
  other related website statistics (for example, recording the popularity of certain website content
  and verifying system and server integrity)

### **HOW WE USE YOUR INFORMATION**

We use information that we collect about you or that you provide to us, including any personal information:

- To provide you with information, products, or services that you request from us.
- To produce, conduct, carry out and improve our events in a way that encourages development and connections between participants, sponsors and other partners. This includes connecting event participants with sponsor companies and partners who are offer platforms and services that may be useful for event participants, and vice versa.
- To present our websites and their content to you, customise and enhance your experience on them.
- To fulfill the purposes for which you provided the information or that were described when it was collected, or any other purpose for which you provide it.
- To provide our partners and sponsors with important feedback about the Blockchain developer community based on your feedback and survey responses.

- To carry out our obligations and enforce our rights arising from any contracts with you, including for billing and collection or to comply with legal requirements.
- To notify you about changes to our events, websites or any products or services we offer or provide.
- To improve our events, websites, products or services, marketing, or customer relationships and experiences.
- To allow you to participate in interactive features, social media, or similar features at our events or on our websites.
- In any other way we may describe when you provide the information.
- For any other purpose with your consent.

# DISCLOSURE AND TRANSFER OF YOUR INFORMATION

We may disclose aggregated information about our users, and information that does not identify any individual, without restriction.

We may disclose or otherwise transfer personal information that we collect or you provide as described in this privacy policy:

- To our subsidiaries, affiliates, or business partners.
- In accordance with applicable law, to a buyer or other successor in the event of a merger, divestiture, restructuring, reorganization, dissolution, or other sale or transfer of some or all of CR3ATORS LAB LTD's assets, whether as a going concern or as part of bankruptcy, liquidation, or similar proceeding, in which personal information held by CR3ATORS LAB about our customers and users is among the assets transferred.
- To third party event sponsors and partners to contact you, which may include marketing their products and services to you. The purpose of these disclosures is to connect event participants with relevant sponsors and partners in order to enhance the experience of event participants and improve the likelihood of success of their projects. Our events and event participants are most successful when participants develop new tools and software that build on existing tools and software owned and operated by our event sponsors and partners. Sponsors and partners offer valuable advice and guidance to event participants on their projects. Connecting participants with sponsors and partners is an integral part of our events and creates a more meaningful experience for participants.
- With respect to survey responses, to give sponsors and partners feedback on events, products and services.
- To contractors, service providers, and other third parties we use to support our business (such as analytics and search engine providers that assist us with website improvement and optimization) and who are contractually obligated to keep personal information confidential, use it only for the

purposes for which we disclose it to them, and to process the personal information with the same standards set out in this policy.

- To fulfill the purpose for which you provide it.
- For any other purpose disclosed by us when you provide the information.
- With your consent.

We may also disclose your personal information:

- To comply with any court order, law, or legal process, including to respond to any government or regulatory request, in accordance with applicable law.
- To enforce or apply our terms of use and other agreements, including for billing and collection purposes.
- If we believe disclosure is necessary or appropriate to protect the rights, property, or safety of CR3ATORS LAB LTD, our customers, or others.

CR3ATORS LAB is based in London, England (UK). However, we may process, store, and transfer your personal information in and to a foreign country, with different privacy laws that may or may not be as comprehensive as UK law. In these circumstances, the governments, courts, law enforcement, or regulatory agencies of that country may be able to obtain access to your personal information through the laws of the foreign country.

By submitting your personal information or engaging with our websites, you consent to this transfer, storage, or processing.

# CHOICES ABOUT HOW WE USE AND DISCLOSE YOUR INFORMATION

We strive to provide you with choices regarding the personal information you provide to us. We have put mechanisms in place to give you control over your information in the following ways:

We ask you not to share your password with anyone. Unfortunately, the transmission of information via the Internet is not completely secure. Although we do our best to protect your personal information, we cannot guarantee the security of your personal information transmitted to our Website. ### DATA RETENTION
